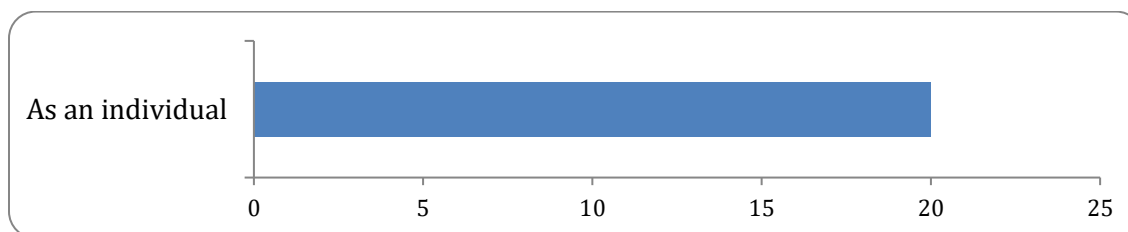

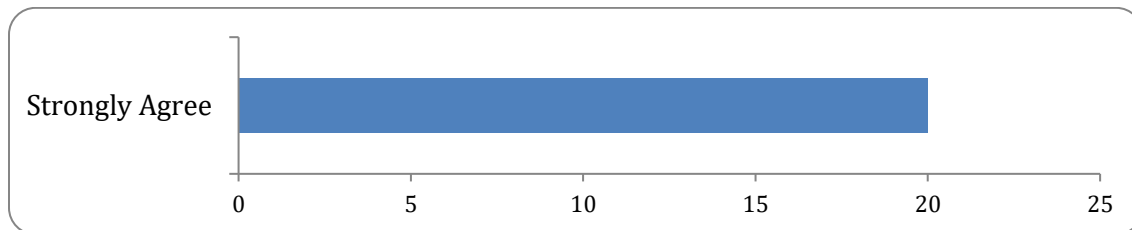

7: Do you have any further comments on the impact of listing or the accuracy of the information in the assessment?

Janie Munro	As a local resident and long time recreational user of the cemetery I wholeheartedly support the proposed listing which will provide a level of protection and possible future maintenance of this rare example of Victorian planned garden cemetery.
Andrew Hill	I walk through the cemetery most days and I find it sad that it has been left to decay. The history in the cemetery is amazing with fallen 1st and 2nd war soldiers, silver screen icons mothers, footballers who started the game in it early years and prominent people of a bygone era. I find it sad that trees are growing in graves and headstones are fallen and knocked over. I would like to see the cemetery brought back to its former glory.
Anonymous	I believe a C listing should put some responsibility on the council to maintain the environment. It's become a community resource which is well used with no funding attached. I believe we should pursue some recommendations alongside the listing to ensure the



	environment is maintained appropriately befitting the vulnerable and respectful legacy it deserves.
