We have only provided responses with the names of individuals in the table row next to the comment if we have been given permission to do so



## 3: Are you responding as an individual or on behalf of an organisation, business or community group?



Moira Shemilt	I am an elected member for Livingston South and the Skatepark is in my ward. It
WORA SHEITIIL	was my motion to full council which generated the request to seek Historic Status for the park. The idea for the motion came from talking to skateboarders. The park has been an integral part of my family's life for many years. My sons were regular users of the skatey as was my son in law. It was the latter who nagged me to "do something" about the park as that there was a worry about it falling into disrepair. My grandkids are now regulars there, with my 9 year old granddaughter now asking for a BMX for Christmas, to use on the skatey.
	We want to see the park conserved, restored and improved, to bring it back to international standard. I the HES report it was mentioned that later additions to the park are less effective than the original bowls and half pipe. It's my hope that historical status could help secure funding for improvement.
