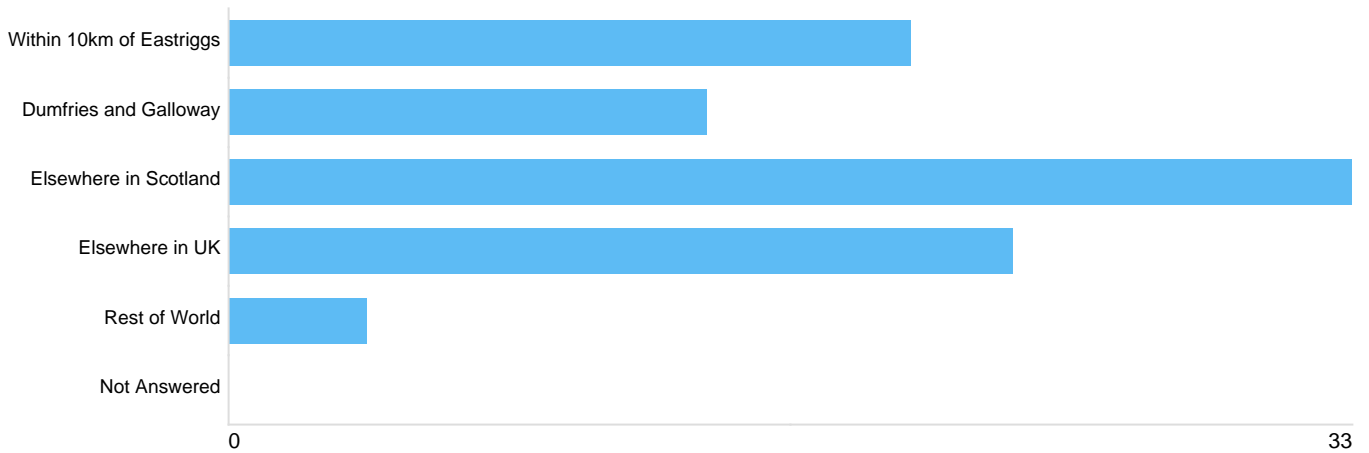

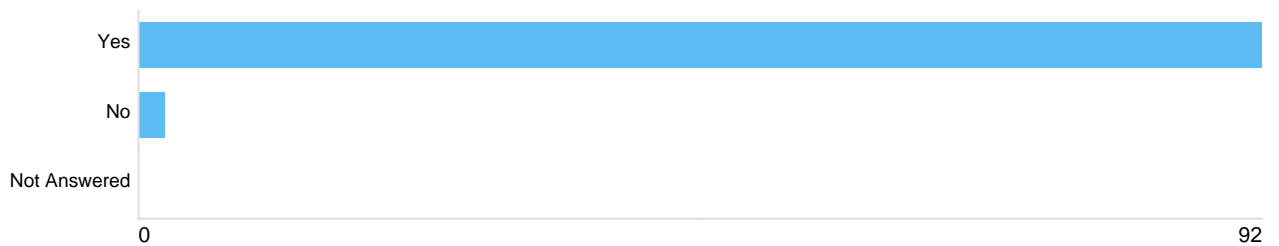

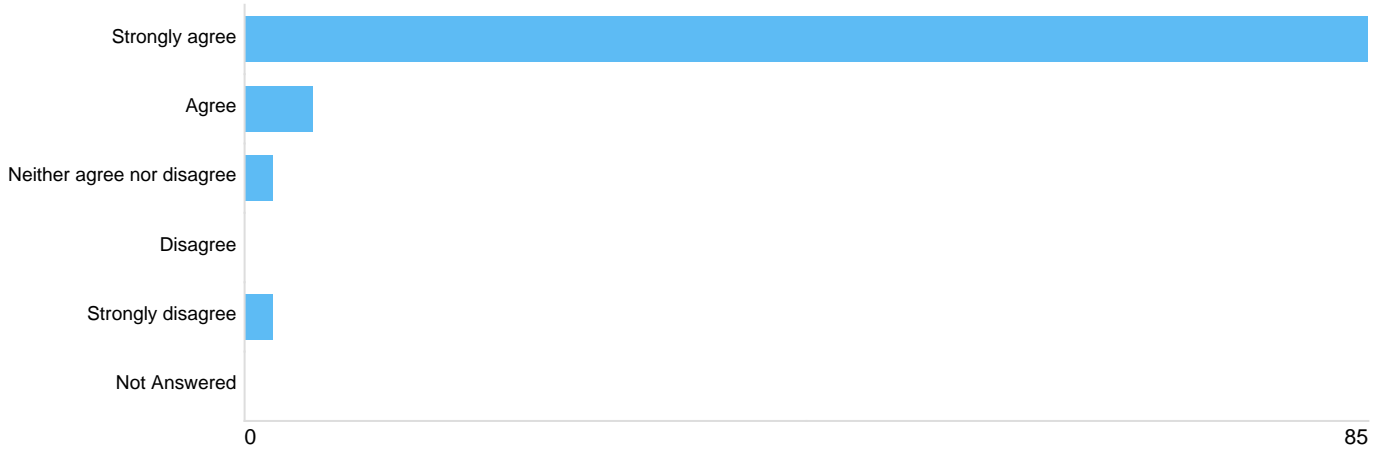

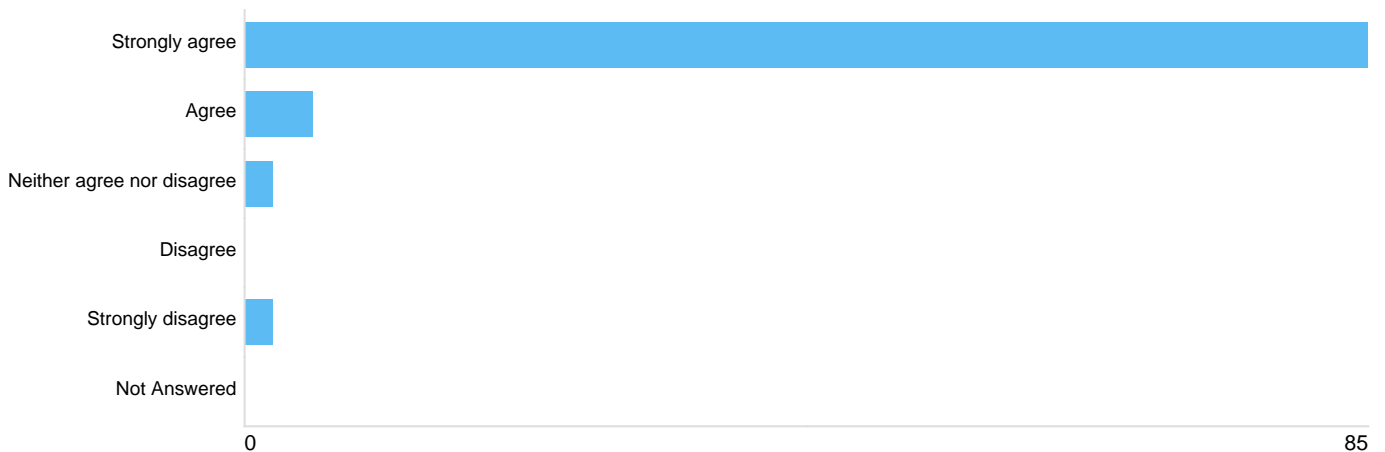

Do you agree with the proposal to designate the site?



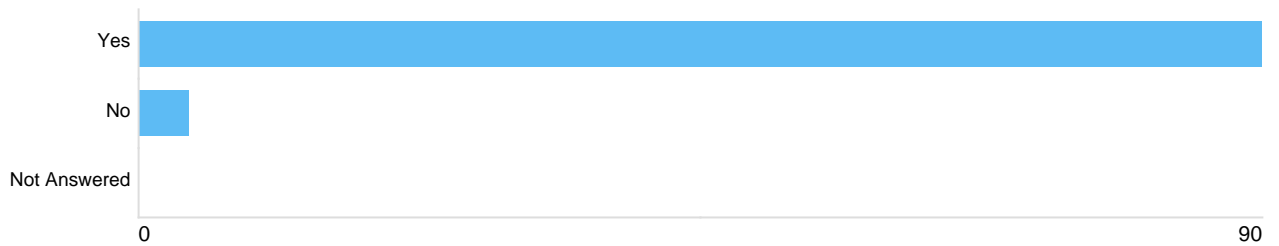
